Yesterday afternoon you received an email notice from Resource Property Management (RPM) titled *Important Communication Regarding 2026 Maintenance Fee* that contained some misleading information that has caused confusion for our homeowners.

It turns out that this message was a general notice sent out to a number of different HOAs served by RPM. It contained information that does not apply to Rosedale.

The correct information is as follows:

The 2026 annual assessment for Rosedale Master HOA is \$2,532 is due as a one-time payment on January 1, 2026. Homeowners have a 30-day grace period in which to pay their annual assessment. Payments not received by January 31<sup>st</sup> will be considered late and be subject to a late charge of the greater of Twenty-five Dollars (\$25) or five percent (5%).

#### **Payment Options**

 Owners currently enrolled in Auto Draft (ACH) do not need to take any action. Your maintenance fee will be automatically deducted on January 3.

## 2. Online Banking:

If you use online banking to process your maintenance fee payment, it is extremely important to verify the following:

- Your account number, which will be listed on the invoice you will receive by mail shortly.

  - i. Credit card payments will incur a 3.25% service fee
  - ii. E-check payments will incur a \$1.99 flat fee per payment

Please disregard any references to *coupon booklets* included in the RPM email, as that option does not apply to Rosedale

The email you received was for notification purposes only. A written invoice was mailed to each homeowner this past Monday and should be received within a few days. The invoice is also available in the Vantaca Homeowner Portal under "Recent Messages" on the home page once you log in.
