As a condition of an ARC approval, property owner(s) recognize that they will incur the entire cost of removing any and all portions of that project that infringes or encroaches on utilities/drainage easements or setbacks on the lot if removal is required, and agree to defend, protect, indemnify and hold harmless the Rosedale Master Homeowner's Association, Inc. from any and every claim or demand, loss and expense of any kind, including attorney's fees, which may ever be asserted against Lot Owner(s), or Master Association, by anyone else, arising out of any damages, loss, personal injury, death, loss of value, or property damages claimed or actually sustained as a result of construction of the modification sought herein.
