Exterior Painting, Added Trim and Gutters & Downspouts - include color samples and paint scheme of colors, i.e., trim, main house, doors, etc. Picture of existing paint scheme. If adding trim items like Shutters, and Gutters and Downspouts, include drawing of placement of items, pictures, specifications and color of trim items and any other project explanation needed

Tree and Plant Removal and/or Replacement- Attach a photo of item to be removed and the reason for same. If being replaced, list the tree/plant(s) to be used remembering we prefer Florida Friendly Flora. (ANNUALS DO NOT REQUIRE ARC ACTION).

Landscaping (including lighting) -Attach site plan with landscaping superimposed thereon, landscape design plan, list of plants indicating Florida Friendly, photos, detailed explanation and description of any other materials to be used. For lighting, attach lighting plan and specifications and where lights will be placed . Photos may be helpful and/or description of project.

Ornamentation - include any Items visible from the front of the property, statues, small garden fountains and benches, cast iron items, pots and baskets, etc. Attach a picture of the item and a picture of where the item is to be included in the landscaping.

Notes:

1. For the protection of homeowner and Rosedale Residents, the Master ARC Committee recommends that homeowners use only licensed and insured contractors on all projects.

2. Residents are responsible for obtaining necessary Manatee County permits for modifications requiring permitting.

3. As a condition of an ARC approval, the property owner recognizes that he or she will incur the entire cost of removing any and all portions of the project that infringes or encroaches on utilities/drainage easements or setbacks on the lot if removal is required. The Master Association will not be responsible for any costs related to such removal.
